- **E. Action Item** on Direct deposit for the city of china Grove using business payroll services through American Bank. Direct deposit will begin on March 30<sup>th</sup>, 2024 payroll date. (\$60.00 a month, with quarterly reports completed, Direct deposit will be mandatory for all paid city of China Grove employees unless proven that a financial institution is unable to provide the employee a service account.
- **F. Action** Item allowing Computer Network Professionals to facilitate the implementation of a new dell workstations, firewall, wireless access points and software to the city of china grove. (Currently there are several wifi communication drops, especially during busy court days).
- **G. Discuss** comparison of City Of China Grove to St Hedwig regarding budgets in income and police expenses.
